PURPOSE OF THE JOB: To aid the development and implementation of IT solutions through business and system analysis and design. To ensure that systems are developed in-line with the current aims, objectives and principles of the Police and Fire. This will include assisting the development and delivery of the Digital and Technology programme of work by supporting the department's change and annual planning processes.

MAIN RESPONSIBILITIES:

1. To undertake feasibility studies and assist in the production of formal business cases for proposed solutions as a basis for decision making at a senior management level.

2. To carry out business and system analysis to develop user requirements for solutions as a basis for their development both in-house and external.

3. To perform analysis of existing systems to provide advice and consultation on current capabilities.

4. To provide gap analysis between existing systems and processes and the required to be state and perform solution identification to meet business needs.

5. To work closely with the Business Engagement leads with the Digital and Technology Department to ensure that business areas across Fire and Police have relevant information related to the technology they use and/or need.

6. To carry out work to support the operation of the departmental and corporate change processes by conducting analysis of business requirements and writing change mandates or business cases as directed by the Solutions Design Manager.

7. To contribute to programmes of work and strategic roadmaps by conducting the analysis of business requirements as required.

NOTE:

The job description reflects the major tasks to be carried out by the post holder and identifies a level of responsibility at which the post holder will be required to work.

In the interests of effective working any major tasks may be reviewed from time to time to reflect changing needs and circumstances. Such reviews and other consequential changes will be carried out in consultation with the post holder. The post holder will be also required to carry out such other duties as may be determined from time to time to be within the general scope of the post.

CONDITIONS OF SERVICE:

The appointment will be full time and subject to the conditions of service of the Police Staff Council.

The annual leave entitlement is 24 days with a further 5 days after 5 years continuous service.
